SIDE AND BEYOND. IN PRE-PANDEMIC TIMES, CLL'S ROBUST ROSTER OF MORE
THAN 30 WEEKLY IN-PERSON CLASSES, DISCUSSION GROUPS AND EVENTS, WITH AN
EMPHASIS ON ARTS AND CULTURE, ENGAGE AND EMPOWER PARTICIPANTS. CLL
PROVIDES A SUPPORTIVE ENVIRONMENT HELPING OLDER ADULTS CONTINUE TO

ELDERLY PEOPLE WHO LIVE ALONE, AND THE WORKING POOR WHO CANNOT AFFORD
TO PAY FOR BOTH RENT AND FOOD. THEY ARE ALSO THE HOMELESS WHO LIVE IN
SHELTERS OR ON THE STREETS. THE COVID-19 PANDEMIC EXACERBATED THE

"CRISIS PREGNANCY CENTERS" (FAKE ABORTION CLINICS). PRO-TRUTH HOSTED A
NIGHT OF EDUCATION AND ADVOCACY IN JANUARY 2020, AND WORK CONTINUED
THROUGHOUT THE PANDEMIC. STAFF AND VOLUNTEERS CONDUCTED RESEARCH ON THE
