**EVEN PRIOR TO THE PANDEMIC, OVER ONE MILLION NEW YORKERS HAD DIFFICULTY AFFORDING FOOD. FOR NEARLY 40 YEARS, NCJW NY HAS PROVIDED NUTRITIOUS FOOD TO PEOPLE IN NEED, SERVED IN A WELCOMING, DIGNIFIED MANNER.
